A few significant changes in New Companies Act 2017 include **Permanent company bench at high court, Concept of Global register, Categorization of companies into public interest companies, medium sized company and small sized companies and more**



Change:

On May 30, 2017, the Companies Act 2017 replaced the Companies Ordinance, 1984.

The changes in Companies Act will impact all major stakeholders across the business spectrum; from simplifying company business, easing regulations for small companies, focusing on the use of technology, enhancing responsibilities of the Securities and Exchange Commission of Pakistan, through to simplified winding up and merger requirements.

2. to help participants learn about financial and disclosure requirements related to reporting;
